#### LIMITED WARRANTY GENERAL CONDITIONS APPLICABLE TO ALL MERCHANDISE AND SERVICES:

ScienceofSpeed, LLC's obligation under this Warranty shall be limited to the repair, replacement, or reimbursement, at its option, of any products or workmanship which may prove defective under normal use within twelve (12) months from the date of sale, and which the examination of ScienceofSpeed, LLC reveals to its satisfaction that the products in question are in fact defective.

This warranty is expressly in lieu of all other warranties expressed or implied including the warranties of merchantability and fitness for use and all other obligations or liabilities on the part of ScienceofSpeed, LLC. The warranty contained herein shall not apply to any part or product which has been subject to accident, alteration, misuse, or abuse. This warranty shall only apply within the boundaries of the continental United States. ScienceofSpeed, LLC makes no warranty against any products ability to protect against injury or death. The purchaser and/or user assumes all risks of damages or injuries, including death.

#### MERCHANDISE:

All merchandise returned for warranty consideration, inspection, repair, etc. must be sent prepaid and insured. Included with this return must be the sender's name, address, phone number, and explanation of the problem. This warranty covers replacement or repair of the product only and does not cover the cost of labor and/or freight. There is absolutely no warranty on the following:

- B) Any product that has been physically altered, or improperly installed or maintained.
- C) Any product used in improper applications, abused or not used in conjunction with the proper parts.
- D) Any wear related item, including but not limited to brake & clutch components.

Warranty claims denied will be returned to customer at customer's expense. Warranty claims denied will be returned in inspected condition & will not be re-assembled. Components of denied warranty claims will be stored for 30 days after customer has been informed of warranty decision. After this period, components will be discarded. ScienceofSpeed, LLC will return approved warranty claims back to customer at ScienceofSpeed's cost via the most economical method possible. Upgrades in shipping service will be at customer's expense.

#### SERVICE:

ScienceofSpeed, LLC makes no warranty whatsoever in respect to components having existing, developing, or hidden failure not repaired or replaced by ScienceofSpeed, LLC. ScienceofSpeed, LLC makes no warranty whatsoever in respect to used or reconditioned components installed. ScienceofSpeed, LLC makes no warranty whatsoever in respect to parts not supplied by ScienceofSpeed, LLC to customer. ScienceofSpeed, LLC makes no warranty whatsoever in respect to any damage caused by parts not supplied by ScienceofSpeed, LLC to customer.

#### ENGINE SERVICE, REPAIR, AND MODIFICATION:

Due to the complexity and critical requirements of the initial engine break-in process, this warranty is only made available for engines that have been removed from customer's vehicle, rebuilt, and re-installed into customer's vehicle at ScienceofSpeed's headquarters. No warranty coverage is provided for vehicles with aftermarket or modified engine management, fuel system, or ignition systems not installed and tuned by ScienceofSpeed, LLC or ScienceofSpeed, LLC's agent.

ScienceofSpeed, LLC warrants engine repair or modifications for 1 year or 12,000 miles (which ever comes first) against defects of parts or workmanship. ScienceofSpeed, LLC makes no warranty against damage caused by user negligence or ignorance including oil starvation, over rev, over boosting, detonation, or other abuse not stated whether damage is caused, related to, or not related to any fuel or fuel and ignition system installed, tuned, or modified by ScienceofSpeed, LLC or ScienceofSpeed, LLC's agent. Due to the increased stress placed on components used in motorsports applications, no warranty is provided from damage or wear on products used in competitive or non-competitive motorsports applications. Upon submission for warranty, ScienceofSpeed, LLC will inspect and make final determination regarding the source of engine failure. Engine removal and tear down for warranty inspection can only be performed by ScienceofSpeed, LLC. Upon event that the warranty claim is denied due to abuse, the cost for removal, tear down, reassembly, and reinstallation will be the responsibility of the customer. This warranty covers replacement or repair of the product or service only and does not cover the cost of labor, freight, and/or transportation of vehicle.
